### 1. THE EVENT

The Event, a **Multi-Club Khanacross**, shall be known as the GMSC & WDCC Avalon Autocross/Khanacross and will hereafter be called the Event. The Event will be held on the 20/03/2022, which will be hereafter called "the Sunday of the Event". The Event is open to members of clubs affiliated with Motorsport Australia in Victoria.

### 5. AUTHORITY

The Event will be held under the FIA International Sporting Code including Appendices and the National Competition Rules (NCR) of the Motorsport Australia, the Khanacross Standing Regulations, these Supplementary Regulations and any Further Regulations or instructions issued.

This Event will be conducted under and in accordance with Motorsport Australia OH&S, Motorsport Australia Safety 1st and Risk Management Policies, which can

be found on the Motorsport Australia website [www.motorsport.org.au](http://www.motorsport.org.au). this Event will be conducted under and in accordance with any and all necessary Motorsport Australia COVID-19 Return to Race Strategy requirements at the time of the event.

### 6. PLACE AND DATE

(a) The Event will be held at the "Geelong Motor Sports Complex" (clay/gravel surface), on the Sunday of the Event at the corner of the Princess Hwy & Beach Rd Avalon. Current Motorsport Australia Affiliated Club Membership Card, Motorsport Australia Licence, and Motorsport Australia vehicle Log Book (if issued) **MUST** be presented at Scrutiny.

(b) Gates will open at 8:00am. Sign-on will be required on entrance to the Avalon Complex.

(c) A **Self Scrutiny Checklist** must be completed prior to the event and be in the vehicle owner's possession during the event.

Vehicle scrutiny will only be required for vehicles not having competed at the Geelong Motor Sport Complex this year or have had repairs or modifications made.

**If your vehicle requires scrutiny, you MUST be in the queue for Scrutiny by 9:30am.**

(d) A compulsory drivers briefing will be by 10:00 am. Official runs will commence by 10:30 am.

(e) Catering will **NOT** be available.

### 7. ENTRIES

(a) Entries and payment will be accepted **ONLY** on the day of the Event.

(b) The Entry Fee is **\$35.00** for Drivers aged 18 years before February 1, or over, and **\$15.00** for class J entries aged 12 up to 18 years. An experienced Instructor as approved by the Clerk of the Course must accompany a driver aged 12 or 13 years.

(c) An Entry will only be termed valid when a current Motorsport Australia Licence and Club Membership is presented, and payment has been received via a bank transfer as indicated in 7(b).

(d) There will be a maximum of three Drivers per Vehicle

(e) A maximum of **50** Entries will be accepted, in order of receipt

(f) The Promoter reserves the right to refuse entries in accordance with the NCR's.

#### 7.1 PASSENGER AS INSTRUCTOR

This Event will NOT include a Motor Sport Passenger Ride Activity (MSPRA).

(d) An entry will only be termed valid when a current Motorsport Australia License, Club membership and vehicle Logbook is confirmed, and payment has been received with the on-line entry application.

(e) There will be a maximum of three Drivers per vehicle.

(f) A maximum of fifty (**50**) entries will be accepted, in order of receipt.

(g) The Promoter reserves the right to refuse entries in accordance with the NCR's.

## 8. INSURANCE

Certain public, property, professional indemnity and personal accident insurance is provided by Motorsport Australia in relation to the Event. Further details can be found in the Motorsport Australia Insurance Handbook, available at [www.motorsport.org.au](http://www.motorsport.org.au).

## 9. CLASSES

A - up to 1300cc standard	B – 1301 to 1600cc standard
C – 1601 to 2000cc standard	D – over 2000cc standard
E – up to 1300cc modified	F – 1301 to 1600cc modified
G – 1601 to 2000cc modified	H – over 2000cc modified
J – Juniors (12 to 18 yrs)	K – Females
L – Specials and 4-wheel drive	

## 10. STARTING ORDER

Starting order will be determined by the organisers and circulated electronically prior to the Event. In the case of shared vehicles, Drivers will be spaced, if possible, several vehicles apart to allow changeovers with minimal disruption to the Event.

## 11. DRIVERS

(a) Drivers must hold a Motorsport Australia **Speed/Junior** Licence or superior.  
(b) All Competitors are required to wear snug fitting clothes covering the body from neck to wrist to ankles and suitable footwear. Clothing should be of a fire resistant nature. For further details, please refer to Schedule D of the current Motorsport Australia Manual.

## 12. VEHICLE ELIGIBILITY

As per the Khanacross Regulations, Schedule A and Group 4K Regulations of the current Motorsport Australia Manual.

- (1) **All vehicles** must utilize two separate fastening systems on any front opening panel.
  - (2) **Fire extinguishers** must be securely fitted to the vehicle to a standard listed in Schedule H of the current Motorsport Australia Manual and in accordance with the Khanacross Standing Regulations.
  - (3) **Safety helmets** must conform to the requirements of Schedule D of the current Motorsport Australia Manual (e.g. AS 1698) and be worn whilst competing.
  - (4) **All vehicles:** (a) Only Passenger vehicle road tyres permitted. Reconditioned tyres may be permitted at the discretion of the Scrutineers. Off road, terrain or winter tread tyres are **NOT** permitted. (b) Tubeless tyres must be fitted to optimum rim size only. (c) Vehicles must have on their coachwork a triangle of 150mm sides indicating the battery location. (d) Mud flaps must be fitted to the driving wheels. (e) Must be fitted with front and rear towing hooks.
  - (5) **Fuel** must be in accordance with Schedule G of the current Motorsport Australia Manual.
  - (6) **All vehicles** must be adequately muffled.
- Any breaches of these Supplementary Regulations will be dealt with in the same manner as breaches of all other Regulations pertaining to the Event.

## 13. EVENT LAYOUT

(a) The Event will consist of up to six (6) tests with each test no greater than 1.5 km in length. (b) No more than two (2) vehicles will be permitted on a course at any one time as per the Khanacross Standing Regulations 1.1.

## 14. RUNNING DETAIL

Results will be determined by adding all the Competitor's run times. The number of runs will be determined by the Clerk of the Course and be dependent on the condition of the track (typically 6 runs). Timing will be by hand held stopwatches. Time starts and finishes when the front of the vehicle passes the start/finish line defines by bollards. This is a Series Event and points will be awarded to the end of year tally.

## 15. STARTING PROCEDURE

Competitors will line up in numerical order and will move into the start garage when signalled by either the green light or the start marshal. Officials may run out of numerical order.

## 16. FINISH PROCEDURE

A run is completed once the Competitor has come to a complete halt within the finish garage. Vehicles are then to proceed immediately off the course. The maximum speed limit in the paddock area is 10 km/h.

## 17. TERMINATION, POSTPONEMENT OR ABANDONMENT OR CANCELLATION AND PROTEST

The Organisers reserve the right to stop the event at any time if they consider it necessary, in the interests of safety or for any other reason.

In the event of a **Total Fire Ban** being declared or **heavy rain**, the event **WILL** be cancelled.

The Organisers reserve the right to postpone, abandon, or cancel the Event under the NCR's, and if the event is cancelled or postponed prior to commencement for more than 24 hours, the entry fees shall be refunded in full.

Protests must be lodged in accordance with the NCR's and accompanied by the appropriate fee.

## 18. AWARDS

Points will not be awarded for individual events, but accumulated for end of year championship points.

## 19. ALCOHOL, DRUGS AND OTHER SUBSTANCES

The holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of any drug or other banned substance and subject to a penalty for a breach of the Australian National Anti-Doping Policy and/or the Motorsport Australia Illicit Drugs in Sport (Safety Testing) Policy at [www.motorsport.org.au](http://www.motorsport.org.au).

Consumption of alcohol in the paddock, pits or any other Reserved Area is prohibited until all Competition is concluded each day. The holder of a Motorsport

Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol by a Motorsport Australia Accredited Testing Official (CATO) in accordance with the Motorsport Australia Alcohol Policy at [www.motorsport.org.au](http://www.motorsport.org.au).

**20. PENALTIES** See section 4 of the Standing Regulations. **Five (5) seconds** will be added to your time for failing to obey instructions given during the drivers briefing. This will include the procedures for returning to the Pits/Paddock.

## Permit Number – 322/2003/03 – FURTHER REGULATIONS

1. The event will be a round of the GMSC/WDCG Khanacross / Autocross 2022 Series AND Round 2 of the Group5 Non Speed 2022 Series.
3. Entries will ONLY be taken on the day of the event. No pre entries will be able to be received (*PO Box on Supp Regs is not available to be accessed*)
7. Entrants may enter in either or both the GMSC/WDCG or Group5 components and must nominate on the Entry Form which GMSC/WDCG and / or Group5 classes they are entering. The cost for entering one or both parts is the same and as per the Supplementary Regulations. Entry costs for juniors entering (only) the Group5 component shall be \$10 as per Group5 Series Regulations.

7.1 This Event will include a Motor Sport Passenger Ride Activity (MSPRA) which shall be run under and in accordance with the Motorsport Australia MSPRA Policy.

A single Passenger is permitted in competing vehicles in the Group5 component, providing they are over 12yo and have signed the Passenger/Driver Disclaimer Form.

Up to 5 adults and any number of juniors may compete in any vehicle, provided that this is indicated on the Entry Form.

9. The Event will have separate class systems for each of the components of the event.

GMSC/WDCG Classes (*As per the Supp Regs*)

Group5 Classes (*As per 2022 Group5 Non Speed Regulations. - Based on vehicle length*)

**Class A:** Up to 4099mm - Engine Over Driven Wheels

**Class B:** Up to 4250mm - Engine Away from Driven Wheel

**Class C:** 4100mm and over - Engine Over Driven Wheels

**Class D:** 4251mm and over - Engine Away from Driven Wheels

**Class E:** All Wheel Drive Production Vehicles

**Class F:** Specials / & Non production cars\*.

**Class J1:** Inexperienced Juniors under the age of 18 as of the first round of the year.

**Class J2:** Experienced Juniors under the age of 18 as of the first round of the year.

**Class L:** Ladies

Juniors and Ladies will be scored on the basis of handicap factors for each class. Handicap factors are as follows:

Class A: 0.95      Class B: 0.90      Class C: 0.93

Class D: 0.86      Class E: 0.94      Class F: 1

7. Drivers in the Group5 component (*other than drivers of open vehicles*) need a helmet, closed shoes, shorts and a T shirt as the minimum apparel requirements (in accordance with Motorsport Australia Schedule D).
12. Vehicles in the Group5 component of the event do not require a battery triangle, mud flaps, towing hooks or dual bonnet restraint systems (in accordance with Motorsport Australia Schedule A).
14. This is a Group5 Series event and Group5 series points will be allocated for any eligible entrants who nominate for the Group5 component of the event.
18. Awards will be provided for the Group5 component of the event in accordance with Group5 Series Regulations. Separate results will be provided for both the GMSC/WDCG and Group5 components of the event, with entrants shown in the component(s) results they have entered
20. Penalties will be awarded as per Group5 Series Rules for the Group 5 component of the event.
